I am writing to inform you of the development of the Garvies Point affordable housing complex. 46 new apartments will be available for rent. The unit mix consists of 4 studio, 15 one-bedroom, 23 two-bedroom, and 4 three-bedroom apartments set-aside for households with incomes at or below 60% and 100% of the Area Median Income (AMI) for Nassau County, adjusted for household size, with rents set at \$1,375, \$1,558, \$1,867, \$2,130, \$2,389, \$2,857, and \$3,289 respectively. Tenant pays electricity, electric heat and electric cooking. Trash removal and sewer included in rent. The apartments are located at 500 & 700 Dickson Street, Glen Cove, NY 11542.

Enclosed is information describing the building and the apartments offered for rent and information explaining how to request an application. Applications must be postmarked by April 17, 2023. A public lottery will be held on May 1, 2023 at 12pm at the Hilton Garden Inn, 3 Harbor Park Drive, Port Washington, NY 11050.

Garvies Point includes 46 visitable units as defined in the NYS HCR Design Handbook. More specifically, Garvies Point includes a minimum of 6 fully accessible and adapted unit for wheelchair use that include a roll-in shower, and a minimum of 3 fully accessible and adapted unit for residents who have a visual or hearing impairment.



- 1. You must fill out the application <u>completely</u> and it must be returned to the address indicated on the application. Applications mailed to addresses other than the indicated address will be disqualified. If <u>unsigned or incomplete</u>, your application may not be considered.
- 2. Information provide on this Preliminary Application will be treated as confidential. All information provided will be verified. If you have intentionally falsified information, your application will be rejected.
- CGMR Compliance Partners will conduct a background check for all applicants. You have the right to review and contest
 the results of the background check and/or present evidence of rehabilitation if your application is denied due to criminal
 history.
- 4. Your household can file only one application, and no household member can appear on more than one application. If you file multiple applications, your application will not be considered.
- 5. Priority for the accessible units will be for individuals and families which require physical accommodations.

- 6. If you are disabled and require an accessible unit, an extra bedroom for equipment or for a Personal Care Attendant, a reasonable modification of the housing, or a reasonable accommodation of rules, policies, practices or services, please include a letter from your qualified third-party professional explaining such special requirements.
- 7. If your application number has been chosen, you will be required to attend an interview and complete a full application packet in order to complete your application.
